RULES AND REGULATIONS

The Deering Estate at Cutler property is managed by Miami-Dade County Parks & Recreation Department on behalf of the State of Florida. Therefore, it is necessary that we ask for your compliance with the following:

- Vendors must adhere to the scheduled set up and take down times.
- Vehicles and trailers are not permitted on the Estate grounds during *Youth Arts Day and Music Fest* hours and may not be used to dispense products without prior written consent of Students Offering Support, Inc./Deering Estate at Cutler staff.
- Vendors must clean up their areas during and at the end of *Youth Arts Day and Music Fest*.
- Vendors and exhibitors must provide tables, table coverings, power source, electrical cords, chairs, decorative accents, and any other equipment necessary to display your goods. **All equipment must be self-supporting, with no nails or other damaging hardware placed in trees, lawn, shrubs, signs, walls, or fences.**
- **NO STAKES ARE PERMITTED ON THE ESTATE GROUNDS. Canopies and tents must be secured using weights, i.e. sand buckets.**
- Access to the Estate for set up will be provided through the Service Gate or the Gate adjacent to the People's Dock on the South side of the Estate.
- Access to the Estate and service area for set-up and day of event is just east of Old Cutler Road and SW 168th Street at 72nd Ave. All parking at the Deering Estate at Cutler is free of charge. **Exhibitor parking is available on the grounds in a designated area HOWEVER once the event begins, YOU CANNOT leave the grounds until it is over and clearance has been given.** Parking is also available outside the main entrance on a first-come-first serve basis.
- All vehicles must be removed from the exhibit area 1 hour prior to gates opening.
- Pets and animals of any type are not allowed on the Estate grounds unless prescribed for medical purposes.
- Helium balloons are not permitted outdoors on the Estate grounds.
- Smoking is not permitted inside any of the historic buildings.
- Students Offering Support, Inc. and the Deering Estate at Cutler would like to portray a professional image and requests that your workers dress appropriately for this event.
- Placement of all vendors and exhibitors is at the sole discretion of Students Offering Support/Deering Estate at Cutler staff.
- This event will be held rain or shine and no refunds will be issued.
- The undersigned grants Students Offering Support, Inc. the right to use company name and/or logo in photographs on film, videotape, or the web as part of our promotional materials and advertising materials for *Youth Arts Day and Music Fest* and may be exhibited and re-exhibited without limitations or liability.

You and your organization shall indemnify, defend, and hold Students Offering Support, Inc., the Deering Estate at Cutler, and Miami Dade County Parks and Recreation Department harmless from and against any and all liability, loss, damage, expenses, court cost, and attorney's fees in connection with, arising out of, or directly or indirectly related to any claim of loss or damage to property or of death or injury to persons, resulting from use of your organization's product or service.
